

# SUMMARY ANNUAL REPORT FOR

## PLUMBERS & STEAMFITTERS LOCAL 21 WELFARE FUND

THIS IS A SUMMARY OF THE ANNUAL REPORT FOR THE PLUMBERS & STEAMFITTERS LOCAL 21 WELFARE FUND, (EMPLOYER IDENTIFICATION NO. 13-4017983, PLAN NO. 501) FOR THE PERIOD JULY 1, 2022 TO JUNE 30, 2023. THE ANNUAL REPORT HAS BEEN FILED WITH THE EMPLOYEE BENEFITS SECURITY ADMINISTRATION, AS REQUIRED UNDER THE EMPLOYEE RETIREMENT INCOME SECURITY ACT OF 1974 (ERISA).

### INSURANCE INFORMATION

THE PLAN HAS CONTRACTS WITH MUTUAL OF OMAHA INSURANCE COMPANY, COMPANION LIFE INSURANCE COMPANY, ANTHEM BLUE CROSS BLUE SHIELD, AND ANTHEM BLUE CROSS BLUE SHIELD TO PAY THE FOLLOWING TYPES OF CLAIMS INCURRED UNDER THE TERMS OF THE PLAN.

ALL LIFE INSURANCE, ACCIDENTAL DEATH & DISMEMBERMENT, HEALTH INSURANCE, PPO CLAIMS

THE TOTAL PREMIUMS PAID FOR THE PLAN YEAR BEGINNING JULY 1, 2022 AND ENDING JUNE 30, 2023 WERE \$1,805,098.

THE VALUE OF PLAN ASSETS, AFTER SUBTRACTING LIABILITIES OF THE PLAN, WAS \$14,905,225 AS OF JUNE 30, 2023 COMPARE TO \$14,156,269 AS OF JULY 1, 2022. DURING THE PLAN YEAR THE PLAN EXPERIENCED AN INCREASE IN ITS ASSETS OF \$748,956. THIS INCREASE INCLUDES UNREALIZED APPRECIATION OR DEPRECIATION IN THE VALUE OF PLAN ASSETS; THAT IS, THE DIFFERENCE BETWEEN THE VALUE OF THE PLAN'S ASSETS AT THE END OF THE YEAR AND THE VALUE OF THE ASSETS AT THE BEGINNING OF THE YEAR, OR THE COST OF ASSETS ACQUIRED DURING THE YEAR. DURING THE PLAN YEAR, THE PLAN HAD TOTAL INCOME OF \$20,673,162. THIS INCOME INCLUDED EMPLOYER CONTRIBUTIONS OF \$18,064,087, EMPLOYEE CONTRIBUTIONS OF \$809,020, REALIZED GAINS OF \$112,774 FROM THE SALE OF ASSETS AND EARNINGS FROM INVESTMENTS OF \$228,212. PLAN EXPENSES WERE \$19,924,206. THESE EXPENSES INCLUDED \$1,050,207 IN ADMINISTRATIVE EXPENSES AND \$18,873,999 IN BENEFITS PAID TO PARTICIPANTS AND BENEFICIARIES.
